

GENERAL CONTRACT CONDITIONS FOR PARTICIPATION IN THE DELTA BIRDING FESTIVAL**1.- ORGANIZATION**

The organization of this DELTA BIRDING FESTIVAL trade fair corresponds to ORYX, FUNDACIÓ CATALUNYA LA PEDRERA, CATALAN INSTITUTE OF ORNITHOLOGY and PHOTO LOGISTICS. For invoicing purposes, the DELTA BIRDING FESTIVAL organization delegates this function to EQUIP BARCELONA 92 S.L.

2.- DATE, PLACE AND TIME

The DELTA BIRDING FESTIVAL trade fair will take place in the month of September 2024, between the 20th and 22nd at the MÓN NATURA DELTA venue in:

On Friday the 20th, the fair's hours will be from 4:00 p.m. to 8:30 p.m., Saturday the 23rd from 9:30 a.m. to 8:30 p.m. (uninterrupted) and on Sunday the 24th from 9:30 a.m. to 3:00 p.m.

Exhibitors will be able to access their stands up to half an hour before opening time and half an hour after closing time.

3.- EXHIBITORS

Companies, individuals, NGOs or any other type of organization will be admitted as exhibitors, duly identified with a Tax Identification Number.

4.- ACCEPTED PRODUCTS

All services, destination promotions, materials, equipment, and services related to ornithology activities, observation and study of nature, ecotourism, nature photography, nature management and conservation and any other activity that may be considered related to the theme of the trade fair may be admitted as exhibitors.

Mockups, models, designs, images, or photographs related to the context of the trade fair can be presented, as well as the presentation of graphics and information related to the company and its activities at their stand.

Exhibited items that, in the opinion of the organization, are not in accordance with the theme of the fair, will have to be removed by the exhibitor without the right to claim or any compensation.

5.- CHARACTERISTICS AND PRICE OF THE STANDS:

3 specific areas are established to hire exhibition spaces.



Zone A - Nature artists:

Activity: *painters, sculptors, decorative arts, photographers, illustrators whose work is related to nature.*

Space type: 3x3 tent with carpet, light point, space labeling (maximum 30 characters), 1 table (200 x 80) and 2 chairs.

PRICE (10% VAT not included): €250 (before July 15), €300 (after July 15)

Additionally, if you hire a tent, it includes:

- A maximum of 5 free tickets (includes stand staff).
- 1 pass per vehicle to a parking lot near the exhibition area.
- Mention, review and link on the website and in the Festival program.

Zone B - Ecotourism:

Activity: *institutions or associations dedicated to the conservation and promotion of nature, active tourism agencies, ecotourism accommodations, stores selling products related to nature.*

Space type: 3x3 or 4x3 modular space with 220V electricity connection, light point, space labeling (maximum 30 characters), 1 table (200 x 80) and 2 chairs.

PRICE (10% VAT not included): 3x3 Space – €400 (before July 15), €450 (after July 15) / 4x3 Space – €500 (before July 15), €550 (after July 15) of July

Additionally, if a space is hired, it includes:

- A maximum of 5 free tickets (includes stand staff).
- 1 pass per vehicle to a parking lot near the exhibition area.
- Mention, review and link on the website and in the Festival program.

Zone C – Optics, video and photography:

Activity: *optical product companies (telescopes, binoculars,...), video or photography, clothing or nature accessories, portable hides, among others.*

Space type: tent with 220V electricity connection, light point, space labeling (maximum 30 characters), platform, 1 table (200 x 80) and 2 chairs.

PRICE (10% VAT not included): €700 (before July 15), €750 (after July 15)

Additionally, if you hire a tent, it includes:

- A maximum of 8 free tickets (includes stand staff).
- 1 pass per vehicle to a parking lot near the exhibition area.
- Mention, review and link on the website and in the Festival program.

6.- STAND AWARDING

Exhibitors will receive communication of the assigned surface and location. The organization reserves the right to modify this surface or location if exceptional circumstances require it, without the right of compensation for the exhibitor. The exhibitor may not offer part or all its stand to third parties without express authorization from the organization.

The awarding of the stand to a company includes the following services:

- Use of space during the exhibition, assembly, and disassembly time.
- The general cleaningservice of common areas.
- The permanentgeneral surveillance service.
- The deliveryof accreditations for exhibitors and stands staff.
- The use of the general servicesavailable.

7.- CONTRACTING OF THE STAND AND SERVICES

Once the applicant's request for participation has been received, the organization will proceed to accept it based on the criteria set forth in these conditions. The exhibitor must comply with the prices, form and payment terms stated therein. No space reservation will be made if it is not accompanied by the corresponding payment. The assembly of the stand cannot begin if the corresponding payment has not been paid. The exhibiting company may choose to contract additional services.

8.- SHIPPING OF GOODS

Starting Tuesday 17th September, merchandise that you want to send by couriers or carriers can be received and stored. On the other hand, collection can be made on 26th and 27th September. It is essential to identify each package with the stand number provided by the organization and the name of the exhibitor. It is highly recommended to indicate on each package the total number of packages sent (for example: 1/3 Stand No. 11 ORYX, 2/3 Stand No. 11 ORYX, 3/3 Stand No. 11 ORYX). 9.- ACCREDITATIONS AND PARKING PASSES

Upon arrival, the exhibitor will go to the equipment reception to request the welcome kit and the corresponding accreditations. The organization's staff will accompany the exhibitors to the corresponding stand. Exhibitor vehicles (maximum 1 per exhibitor) have a reserved space available in one of the parking lots. Accreditation for the corresponding car will be provided within the welcome pack.

10.- ASSEMBLY OF THE STANDS

The stand assembly time is Thursday 19th September from 4:00 p.m. to 8:30 p.m. and Friday 20th September from 9:00 a.m. to 2:00 p.m. All stands must be set up before 3:00 p.m. on September 20th, 2024. Access to an area close to the stand will be possible to unload material until noon on Friday, September 20th.

Vehicle access to the exhibition area will not be permitted during the fair, neither in the morning nor at night, without prior authorization from the organization. The organization may use the stands or spaces that have not been occupied and decorated within this period. In this case, the exhibitor will be considered to have waived his participation and will be liable for the rental amount, the amount of the services already supplied, and the work already carried out at his own expense.

11.-PERFORMANCE DURING THE FAIR

Exhibitors are obliged to keep their stand open and attended during the official DELTA BIRDING FESTIVAL hours. The exhibitor will be responsible for his/her stand and the material on display throughout the duration of the day until the closing time of the trade fair.

The exhibitor undertakes to keep the stand clean and in optimal conditions in all aspects. The exhibitor agrees not to make advertising, calls or play music at high volume that may disturb visitors and other exhibitors at the fair. The exhibitor agrees not to clean or place any goods during opening hours.

12.- EXPOSABLES MERCHANDISE

It is prohibited to exhibit those items that, due to their nature, may present a danger to the public or a nuisance to other exhibitors.

The packaging of the goods may not remain in the fairgrounds during the fair.

If the products offered require so, have the health record of the products in your possession and/or the valid food handler card.

13.- DISASSEMBLY OF THE STANDS

The disassembly of the stand may begin from 3:00 p.m. on Sunday, September 22, allowing access by vehicle to collect merchandise from that time onwards.

It will not be allowed to abandon and remove merchandise or exhibition material before the official closing of the fair. The organization will not be responsible for any damage or loss of exposed materials during the assembly and disassembly work of the stands. For these purposes, each exhibitor must ensure the interests of their stands during these tasks.

14.- DAMAGE CAUSED TO THE FACILITIES

At the end of the exhibition, the stand, as well as the rented material and furniture, must be left in the same conditions in which it was delivered. All damages caused by the exhibitor to the venue and its facilities will be repaired at the exhibitor's expense.

15.- EXEMPTION OF RESPONSIBILITIES

The organization is not responsible for any damage that may be caused to exhibitors, their staff and their materials on the exhibition grounds. Nor is it responsible for any possible damage caused to visitors by exposed mechanisms or materials.

16.- INSURANCE

The organization will take out Civil Liability Insurance for third parties with basic and mandatory coverage, for all purposes of damages caused during the celebration of the fair. In no case will the organization or the organization's staff be responsible for any loss or damage to the material and objects found at the stand, which will have to be insured by the exhibiting company itself.

17.- OTHER MANDATORY RULES

The exhibitor is obliged to respect all current legal provisions in relation to its activity.

18.- CLAIMS

Possible claims must be addressed in writing to the organization that will decide without appeal.

19.- FORCE MAJEURE

In case of force majeure, the dates of the fair may be modified, or its celebration cancelled. In the latter case, the payment already made for the rental of the stand will be returned to the exhibitor, without any claim being made for alleged damages and/or losses as a result of the cancellation.

20.- FINAL PROVISIONS

FIRST.- The organization reserves the right to establish new conditions of participation with respect to all cases not foreseen or that are considered doubtful in these Conditions of Participation, its executive decisions being considered immediately pronounced.

SECOND.- Any violation of any of the previous sections may lead to the immediate, temporary or permanent exclusion of the offending exhibitor.

THIRD.- Exhibitors will establish an address to which appropriate communications can be directed.

FOURTH.- Regarding disputes that may arise between the exhibitors and the organization of the fair, both parties waive their own jurisdiction and expressly submit to the jurisdiction and competence of the courts of the city of Barcelona.
